**I AM A CLOSE CONTACT TO A CASE OF COVID-19. I AM FULLY VACCINATED
(14 DAYS PAST THE SECOND DOSE OF A 2-DOSE SERIES OR 1-DOSE OF A 1 DOSE SERIES COVID-19 VACCINE)
OR
I AM WITHIN 90 DAYS OF A RECENT COVID-19 INFECTION**

FIRST:

Do you have symptoms of COVID-19? If yes, isolate at home and leave home only to get testing. If you do not have symptoms of COVID-19 or have a negative test, then:

- What was the date of your last contact with the positive case: _____?
- Now get a calendar and count off the next 14 days (For example: date of last contact is August 1, 2021. That is Day 0. 14 days of quarantine is through August 15, 2021). Write down your Day 14 date:

SECOND: Follow directions below based on your status

I am fully vaccinated, and I am well.

- Congratulations on being fully vaccinated! You are exempt from staying home during quarantine.
- We strongly recommend that you:
 - Get tested* 3-5 days following date of last contact. (For example: date of last contact is August 1, 2021. That is Day 0. Day 3 – 5 are between August 4-6, 2021)
 - Wear a mask in public indoor settings for 14 days since date of last contact or until you receive a negative test result.
- If you develop COVID-19 symptoms, stay home from work and community activities, seek medical evaluation AND obtain testing. Notify provider of your vaccination status:
 - If result is negative – Stay home until symptoms resolve including fever or follow any return to work criteria of your workplace/school.
 - If result is positive – Notify your employer that you will need to isolate at home. See “I AM A CASE” instructions. NOTE: Cases of COVID-19 are rare in fully vaccinated individuals.

I recovered from COVID-19 infection in the past 90 days, and I am well.

- You are exempt from staying home during quarantine.
- Monitor your health for symptoms of COVID-19 for 14 days since date of last contact with case.
- If you develop COVID-19 symptoms, stay home from work and community activities
 - Seek medical evaluation
 - Follow advice of healthcare provider regarding return to work and community activities.

If you have a serious chronic medical condition and become ill with COVID-19 symptoms, you may be at risk for more severe illness from COVID-19. Please call your doctor for additional guidance.

Florida Department of Health Emergency Rule 64DER21-12 provides opportunities for public school students to reduce quarantine or isolation if they are asymptomatic and receive a negative diagnostic test for COVID-19.¹ If a public school student is using one of the opportunities, as described in Emergency Rule 64DER21-12, to obtain a diagnostic COVID-19 test result to shorten their isolation or quarantine period, the COVID-19 diagnostic test should have received Emergency Use Authorization (EUA) from, or full approval by, the Food and Drug Administration (FDA) and the COVID-19 test should be used in the same manner specified by FDA's authorization or approval. The table below lists current COVID-19 diagnostic tests that have received an EUA by the FDA and how they can (i.e., over the counter or at-home) and should (i.e., symptomatic and/or asymptomatic) be used.
